
Learn accounting and financial reporting principles and practices for for-profit entities. An emphasis will be made on the FASB codification.

NOTE #1: There are NO EXTRA CREDIT assignments available for this course.

NOTE #2: Requests for Incomplete Grades: Incompletes will only be given in emergency or other extreme circumstances. Where possible, requests should be submitted in written form and must include an address and telephone number where you may be contacted throughout the following semester.
