**Prerequisite:** ACCT 3303 or permission of department chair

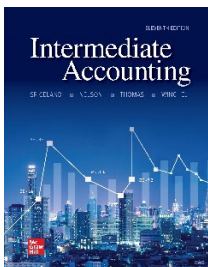
### Course Objective:

  - Become familiar with GAAP and the FASB codification requirements.
  - Categorize cash flows.

## **COURSE REQUIREMENTS**

There will be a variety of graded and non-graded activities throughout the semester.
