- Assemble Recital Committee
- Choose recital repertoire
- Plan and coordinate recital
- Publicize Recital
- Pass a Recital Hearing
- Perform appropriate-level recital

### **LATE WORK POLICY**

All assignments will be due by the dates posted. Each day late will result in 10% off the earned grade. After 10 days, no credit will be earned, and you may lose the ability to have a poster or a program for your guests.

## Grading Criteria Rubric and Conversion

Grades will be assigned at the end of the semester on the following basis:

A = 90-100% represents exceptional demonstration of deep, coherent, unified understandings

B = 80-89.9% represents proficient overall understanding

C = 70-79.9% represents acceptable understanding in most areas of theory and practice

D = 60-69.9% represents developing understanding with some critical deficiencies

F = 0-59.9% represents unsatisfactory understanding with significant deficiencies remaining

## Posting of Grades

Student grades will be entered in CANVAS at the conclusion of the semester.

## COURSE OUTLINE AND CALENDAR

### Complete Course Calendar

The following are recommended guidelines for recitals. If your committee chooses to deviate from these recommendations, that must be agreed to when the program is set, 3 weeks into the semester:

- 30-60 minute recital (BM), 20-30 minute recital (BM with Teacher Certification)
- Must have music representing at least 3 eras of Music History (Medieval/Renaissance, Baroque, Classical, Romantic, 20<sup>th</sup> Century, 21<sup>st</sup> Century)
- Must have original Program Notes for each selection
- For Vocalists, must sing in 4 languages and provide translations of foreign language texts

### Timeline

- 3 weeks into semester (by Feb. 7) - set a recital date by conferring with teacher/committee/accompanist/Jan/Michael, submit program (list of works and composers only) and secure accompanist and evaluation committee. Evaluation committee should be made up of private teacher plus 3 full-time faculty members. (10% of grade, minus 1% for each day late)
- 1 month from Recital Date – Draft and submit a press release or a poster to publicize your Recital (10% of grade, minus 1% for each day late) [8 Simple Steps to Formatting a Proper Press Release \(cyberprmusic.com\)](#) [Free printable, customizable concert poster templates | Canva](#)
- 3 weeks from recital date – submit all program information including program notes and translations (10% of grade, minus 1% for each day late) [Write Program Notes - Music - Research Guides at Syracuse University Libraries](#)
- 2 weeks from recital date – have a hearing with 2 faculty members plus private teacher to ensure Recital readiness. It is the student's responsibility to schedule the hearing and secure accompanist and faculty members to attend. You will not be allowed to present a public recital unless you pass the hearing. (Notice that this is not your full recital committee.)
- Recital - Secure 3 faculty members PLUS private teacher to attend recital. The three faculty members will submit a holistic letter grade for the recital which will be averaged together (70% of grade)

Faculty cannot drop students; this is always the responsibility of the student. The Registrar's Office will provide a deadline on the Academic Calendar for which the form must be completed. ### **University Library & Archives**

The University Library & Archives provides many services in support of research across campus and at a distance. We offer over 200 electronic databases containing approximately 400,000 eBooks and 82,000 journals, in addition to the 96,000 items in our print collection, which can be mailed to students who live more than 50 miles from campus. Research guides for each subject taught at A&M-Central Texas are available through our website to help students navigate these resources. On campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

Research assistance from a librarian is also available 24 hours a day through our online chat service, and at the reference desk when the library is open. Research sessions can be scheduled for more comprehensive assistance, and may take place virtually through WebEx, Microsoft Teams or in-person at the library. ### **University Writing Center**

University Writing Center: Located in Warrior Hall 416, the University Writing Center (UWC) at Texas A&M University–Central Texas (A&M–Central Texas) is a free service open to all A&M–Central Texas students. The hours of operation are from 10:00 a.m.-5:00 p.m. Monday thru Thursday in Warrior Hall 416 (with online tutoring available every hour as well) with satellite hours available online only Monday thru Thursday from 6:00-9:00 p.m. and Saturday 12:00-3:00 p.m.

Tutors are prepared to help writers of all levels and abilities at any stage of the writing process. While tutors will not write, edit, or grade papers, they will assist students in developing more effective composing practices. By providing a practice audience for students' ideas and writing, our tutors highlight the ways in which they read and interpret students' texts, offering guidance and support throughout the various stages of the writing process. In addition, students may work independently in the UWC by checking out a laptop that runs the Microsoft Office suite and connects to WIFI, or by consulting our resources on writing, including all of the relevant style guides. Whether you need help brainstorming ideas, organizing an essay, proofreading, understanding proper citation practices, or just want a quiet place to work, the UWC is here to help!

Students may arrange a one-to-one session with a trained and experienced writing tutor by making an appointment via [WOnline](https://tamuct.mywconline.com/) [https://tamuct.mywconline.com/].
