COURSE INFORMATION

Course Description: Race & Ethnicity in Criminal Justice (**3-0**). A review of current research guides our examination of the relationship between minorities and law enforcement overtime, relevant social issues today, the racial profiling phenomenon, and the influence of race/ethnicity on trials, sentencing, and corrections.

Course Objectives:

1. Explore the state of racial and ethnic relations in the U.S. and the criminal justice system.
2. Gain a deeper understanding of the racial profiling phenomenon.
3. Explore the relationship between race/ethnicity and the courts.
4. Explore the relationship between race/ethnicity and corrections.
5. Analyze current events with a deeper understanding of race, ethnicity, and justice.

STUDENT-INSTRUCTOR INTERACTION

This is a web-based class. Most communication between the instructor and students will be via Canvas and email, though all students are able to schedule a telephone conference or meet with me.

I will check and reply to student emails on a daily basis – students should expect a response within 24 hours. Any deviations from this will be announced on Canvas. Checking Canvas frequently is important as this is where any class announcements will be posted.

REQUIRED COURSE WORK

I. 6 Discussion posts 50 pts each (300 pts)

Six discussions will be posted on Canvas during the term. Please read the directions for each entry at the beginning of the week. Some require you to watch videos while some require you to find things on your own. Your response will be posted to where the entire class can view the response. HOWEVER, you cannot view ANY responses until you post. This avoids getting answers from another student’s post.

You can find additional information regarding discussion requirements on Canvas.

II. 5 Journal Article Discussions 40 pts each (200 total pts)

Each Student is responsible for finding, reading, and summarizing 5 peer reviewed articles throughout the course. Students will find a peer reviewed article using the University Library. The article MUST cover some component of race and the criminal justice system. The article should be related to the topics we are currently covering.

Students will complete the following by replying to the discussion prompt in the modules:

1. Provide the citation for the article in APA style (10pts)
2. Provide a summary for the article (15pts)
3. Upload the full text of the article (all or nothing)
4. Post a question relating to the article or topic for that week (5 pts)
5. Reply to at least 2 other student’s questions (20pts)
 - a. Students should refer to the information on discussion questions for guidelines on how to reply to the questions.

III. Annotated Bibliography (2) 100 points each (200 total)

Students will submit two annotated bibliographies. Each annotated bibliography will have a total of 5 articles. You may use the same articles used during discussions. However, copying and pasting is considered academic dishonesty and will be treated as such.

You can find additional resources for annotated bibliographies in Canvas. Please note the following:

1. You will have 3 parts to each bibliography: citation, a concise summary, and a succinct critical analysis on the article.
2. Each bibliography will be a maximum of one page.
3. Your final product should be 6 pages: 1 title page and 1 page per article.

IV. Literature Review (200 points)

Students will write a literature review on one of the topics we are covering. Additional information can be found in Canvas. Here are key points:

Topics submission: 25 pts Due 2/5

1st Draft: 25 pts Due 4/16

Final: 100 pts Due 5/8

In this paper, students will review prior research on their chosen topic and present the empirical evidence (or lack thereof) for the topic, as well as discuss what should still be researched. Students must use at least five peer-reviewed journal articles (peer-reviewed, original research articles). Complete instructions may be found under Modules/Final Paper/Final Paper Guidelines.

OTHER INFORMATION REGARDING THE COURSE

I. Late assignments: Late assignments will not be accepted. **All assignments are due by Sunday at 11:59pm of the week.** For example, any assignments due during the week of 1/23/23 are due by 11:59 on 1/29/23. The literature review is the only deviation from this as it is due on 5/8.

II. Supplementary Material: Additional information will be given to supplement the topics we cover. You are responsible for all information in the supplementary material.

III. Extra Credit: Extra credit is not available in this class.

IV. Note: I will ONLY accept assignments that are submitted properly: through Canvas. Do not email or send me a message with an attachment. You MUST submit the

assignment in the appropriate location within the assignments section. Additionally, if you have questions....ASK! Do not delay, if you are receiving low grades on your discussions and do not know why....ASK!
