This course provides a general overview of research in the field through an introduction to research methodologies and basic statistics.


# **Course Student Learning Outcomes (CLOs)**

- 3. Demonstrate an understanding of basic descriptive and inferential statistics.
- 4. Develop a mock research project [proposal].

### COURSE REQUIREMENTS (Brief overview; more details and grading rubrics in Canvas)

- 1. **Discussions**. Participation in class discussion is an important part of learning. There will be opportunities for synchronous (live) and asynchronous discussion of course concepts and projects. These conversations will not be graded but will help you with your learning.
- 2. **Quizzes**. There will be weekly quizzes over course concepts. These are low-stakes and designed to emphasize learning for mastery. More details are provided in Canvas.
- 3. **Annotated Bibliography**. You will complete a tutorial, then compile and submit your annotated bibliography. We will discuss the purpose of the assignment and how it supports your research proposal. More details are provided in Canvas.
- 4. Leadership Interview Essay. We will have at least one guest interview for the class. You will two submit interview questions and can participate during the interview (if your schedule allows). The questions should focus on leadership philosophy and topics related to educational research. Based

on the interview, each student will write a reflective essay of at least five pages. More details about expectations are included in Canvas.

- 5. **Mock Research Proposal**. This is the major project. You will submit a Research Proposal following the course guidelines, APA format, and our discussions in Canvas. Note, you will not conduct the research project; this is an exercise in working through the steps required for a research proposal. Instructions and expectations are provided in Canvas.
- 6. **Final Exam**. You will take the timed final exam online during the last week of the course. You will have 90 minutes to complete the multiple choice, true-false, and short essay questions. The Canvas timer starts when you open the exam, so you need to be prepared to complete it at that time. The questions come from our course materials and discussions, and they are aligned with our Course Learning Outcomes. The questions address the definition and purpose of educational research, foundations of educational research, different aspects of various research methodologies and statistics.

- Annotated Bibliography & Tutorial (15-points total)
- Leadership Interview Questions & Essay (20-points total)
- Research Proposal (**30-points**)

Final Grades will be computed according to the following scale:

- C = 70-79.9% (105-119 points)
- D = 60-69.9% (90-104 points)
- F = 59-0% (0-89 points)

- Students will submit their work through the assignment submission pages in Canvas. The instructor will review and return student work through the Canvas grade book. Students can monitor their status in the course through the Canvas grade book, as well.
- Assignments are due by midnight (Killeen, Texas time) on each due date.
- Brief assignments such as quiz feedback will be returned no later than the following Wednesday morning. Longer assignments, such as the Leadership Interview Essay will be returned no later than the following Sunday. Students will be notified of any delays.

- All late work must be submitted before July 28.
