COURSE INFORMATION

Course Overview and description

Focuses on the craft and art of creative expression within one genre or a set of related genres. Attention to the conception, design, and execution of the whole work and of elements of figurative language, characterization, dialogue, point of view, and poetic structure, as well as other elements of the craft. Prerequisite(s): ENGL 1301.

Course Objective or Goal

The purpose of the course is to make you a better writer of poetry and get to you excited about the creative process. Our course will explore poetry forms, styles, and great poets, while we practice of writing our own poetry. This course asks students to both analyze and critique both published writers and the work of their peers. Students will also be asked to produce their own original mini-chapbook, consisting of five original poems. Course work will include regular reading assignments of poetry and about poetry. Our online class will consist of weekly readings and discussions, writing exercises, and critique/workshop sessions.

Student Learning Outcomes

- Recognize the special genre of poetry by reading and discussing the work of published poets.
- Understand poetic forms and styles and the literary language of discussing poetry.
- Practice skills in critical reading and writing.
- Review publication conventions and apply standards of professional submission preparation.
- Practice critical approaches and exercise sensibilities through interactions with peers in the workshop process.

Creative works often cover vulnerable and controversial subjects. Students should be able to tolerate innovation, viewpoints different from their own, as well as creative and cultural diversity in the arts.

Required Reading and Textbook(s)

The Oxford Book of American Poetry by David Lehman, 2006.

The Triggering Town: Lectures and Essays on Poetry and Writing by Richard Hugo, 1979.

This course makes use of several other texts, essays, and poems. Links to these sources will be available on a weekly basis through Canvas or provided by the instructor.

COURSE REQUIREMENTS

Course Requirements:

Regular Reading Assignments:

The readings in this course lay the foundation for all the discussions and work we will do. Therefore, these readings are essential to your success in the course. Please be sure that you have carefully read the required assignments before class and be ready to engage in conversation and debate on the topics, themes, and issues addressed in the readings.

Class Lectures:

Class lectures, readings, videos, and discussions are the primary method of instruction and learning in this course. In addition to discussing and debating the issues and themes of our weekly reading assignments, we will be constantly engaging with a variety of poetry, chapters, and essays. I'm interested in an organic learning environment that naturally reflects and engages the interest of the class and will often introduce topics and writings related to our current discussions. To provide space and accountability of our readings in an online class, we will use the discussion board and reflection papers.

Participation in Class Discussions, Writing Exercises, and Workshops (Total 35 points):

Students are expected to participate online often during the week and engage regularly and often in class discussion and workshops. We will have assignments you will complete and turn in to the instructor, and others you will share with the class, both written exercises and reading assignments. Your engagement with the course material benefits the entire class, and you will be graded on your thoughtfulness and your level of engagement with these materials and your classmates. Students who engage often on the discussion board with meaningful responses and attempts at the exercises will score well in this area.

Critique and Imitative Sample (15 points):

Our first major assignment asks you to examine a writer who inspires your own work. You will offer a critique of their most recent work, examining their persona, style, process, and influence. You will also produce and share your own imitative piece written in response or in the style of your chosen author. You will share this with the class in the appropriate discussion forum.

Written Critiques/Peer Review of Poems (20 points):

Our second half of the semester will focus on writing workshops, where students will both write their own original work and provide written and verbal critiques on every short story submitted to the group. These written comments will be graded on the level of engagement and thoughtfulness of the critiques based on the formal and thematic aspects of the stories offered by each student.

Final Portfolio (30 points):

Our final project for the class will be due at the end of the semester, where each student will submit a mini chapbook of five poems ready for submission, a cover letter for publication, and a 1000-word essay that clarifies and describes how their writing process, voice, style, form, and subject matter has evolved over the semester.

Grading Criteria Rubric and Conversion

Final grades will be calculated using the following percentages:

Participation in Class Discussions, Writing Exercises, and Workshops = 35%

Critiques and Imitative Writing Sample = 15%

Written Critiques/Peer Review of Poetry = 20%

Final Portfolio and Essay = 30%

Posting of Grades

All assignments are generally graded within one week of submission. Grades will be posted in Canvas.

Grading Policies

Neither late work nor make up work will exist in this class. Assignments that fail to be submitted by the deadline will not be permitted (unless you have specific approval from me for unexpected and uncontrollable extenuating circumstances that occur before the due date). Likewise, I do not assign extra credit; therefore, students should focus on providing their best work on assignments throughout the semester.

The University Library & Archives provides many services in support of research across campus and at a distance. We offer over 350 electronic databases containing approximately 631,525 eBooks and 75,149 journals, in addition to the 97,443 items in our print collection, which can be mailed to students who live more than 50 miles from campus. Research guides for each subject taught at A&M-Central Texas are available through our website to help students navigate these resources. On campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

Research assistance from a librarian is also available 24 hours a day through our online chat service, and at the reference desk when the library is open. Research sessions can be scheduled for more comprehensive assistance, and may take place virtually through WebEx, Microsoft Teams or in-person at the library. University Writing Center: For the summer semesters, all University Writing Center (UWC) tutoring services are entirely online. The hours of operation are from 10:00 a.m.-4:00 p.m. Monday through Thursday with additional hours Monday through Thursday nights from 6:00-9:00 p.m. The UWC is also offering hours from 12:00-3:00 p.m. on Saturdays.

Tutors are prepared to help writers of all levels and abilities at any stage of the writing process. While tutors will not write, edit, or grade papers, they will assist students in developing more effective composing practices. Whether you need help brainstorming ideas, organizing an essay, proofreading, understanding proper citation practices, or just want a quiet place to work, the UWC is here to help!
