# **COURSE INFORMATION**

# **Course Overview and description**

This course develops the understanding of the role of social workers within the criminal justice and legal system. This course will focus on theory, intervention, and advocacy with diverse forensic populations including adults, people accused of crimes, victims of crimes, and related systems.

#### **Course Objectives**

#### **Student Learning Outcomes:**

- 1. Define Forensic Social Work and basic terminology used in the field, and understand the convergence of social work and the criminal justice system
- 2. Explore the ethical dilemmas inherent in forensic social work. For example, our ethical obligation to advocate for a clients' self-determination contrasted with the needs of the community for safety and justice
- 3. Critically evaluate the effectiveness of existing programs for offenders, victims of crime, and families
- 4. Understand how biological and environmental risk and protective factors lead to criminal trajectories and the types of intervention strategies to improve outcomes
- 5. Apply the principles of evidence-based practice and restorative justice in treatment, program development and evaluation, assessment, planning, and interventions with individuals, groups and communities
- 6. Demonstrate respect for the dignity and worth of clients and victims of crime
- 7. Apply the NASW Code of Ethics to practice in the criminal justice system

#### **Competency Goals Statements (Certification or Standards)**

The Social Work Program curriculum is rooted in a framework established by the Council on Social Work Education (CSWE). Specifically, the program endeavors to develop social workers that promote human and community well-being by being able to demonstrate the following 9 core competencies upon graduation:

Each core competency has specific, measurable practice behaviors that help students and their professors determine if the competency has been achieved. There are 41 total practice behaviors. The complete list of practice behaviors can be found by reviewing the student handbook.

# **COURSE REQUIREMENTS**

Course Requirements:

**Quizzes** (4 Quizzes at 10 points each = 40 points total)

There will be 4 quizzes in this course that cover content from the textbook. Quizzes will consist of a combination of multiple choice and true or false questions. Quizzes will be untimed and you will only have ONE attempt at taking them. There will be NO MAKEUPs allowed for any missed quizzes, as you will be given one week to complete them. All assignments will open on Monday at 9AM and will close the following Sunday at 11:59 PM to allow you time to complete them at your own pace.

**Journal Article Reviews:** (2 @ 10 Points = 20 Points - Due by 11:59 PM July 11<sup>th</sup> and July 25<sup>th</sup> @ 11:59 PM)

Students will select a journal article topic discussed in the course related to Forensic Social Work and the Criminal Justice system. Examples of articles will be provided on Canvas. The article of choice



should be evidence-based and academic in nature. Essay should be at minimum one-page and written in APA format with proper citations. Grading is based most heavily on the content and student perspective. Some interesting topics are listed below, but students have the freedom to choose a topic that is most relevant/interesting to them.

Examples of topics: Prison overcrowding, pregnancy in prison, imprisonment vs mental health treatment, discrimination/justifiable treatment of sex offenders, identifying sex trafficking victims, incarceration vs rehabilitation, substance abuse, recidivism, racial profiling, POC in the criminal justice system, etc.

#### **Expert Witness Response Paper** (10 Points):

Students will write a 1-2 page response summarizing the Social Work topics covered in the assigned interview (i.e. rehabilitation, advocacy, etc...), and one paragraph providing insight and feedback on the topic and how it relates to Forensic Social Work. Students will also share a paragraph on what they learned from this interview.

#### **Discussion Boards/ Participation (5 Points)**

Class will be held via Webex once a week on Monday during our normally scheduled class time of 11:00 am-1: 30 PM. You will be expected to attend class regularly and participate. Please remember professional etiquette when meeting virtually. This means no driving; no background distractions, and being in a quiet place where you can engage with our meetings. Please also remember to be dressed appropriately. In addition there will be discussion boards throughout the course posted underneath the weekly Canvas modules. Each of these discussion boards will be for credit and you will not be able to make them up so please plan accordingly to complete them on time.

**Problem Identification and Response Paper** (25 Points) DUE BY FRIDAY 8/13 at 11:59 PM (last official day of class)

Students will select a problem area within the realm of Forensic Social Work and discuss possible solutions to improve / help correct the problem. Further details will be provided on Canvas surrounding this assignment and expectations.

All written assignments are expected to be the original work of the student. While paraphrasing and some direct quotations are permitted, it is expected this will be done within the context of your own analysis and synthesis of the information read. Paraphrasing is a skill of reading information and, using your own thoughts, summarizing the information in a way that supports the topic discussed. While the paraphrase involves your own thoughts, it originates from a source and that source is cited. Quoting is a matter of taking words, verbatim, from another source and restating them without, or with minimal, manipulation. Quotations are placed in quotation marks ("") or placed in a block format within the text. Quoting does not involve analysis and synthesizing and, therefore, does not require critical thinking except when used appropriately to support (not substitute) an idea. Because of this, students are discouraged from using significant quotations as this limits your learning experience. Students



found to excessively quote will be penalized. Students using words as their own without appropriately citing will be penalized – including failing the assigned project and up to failing the course. Students found to have plagiarized (using words as your own without giving proper credit, whether paraphrasing or directly quoting) will also be referred to the Student Affairs. Therefore, it is VERY important that students take academic integrity in writing very seriously. If you are in doubt, it is always best to cite your source and/or speak with your professor for more guidance. The Writing Center and Purdue OWL are also resources that can help you.

With regard to submitting assignments online, all <u>assignments must be turned in (received by the instructor) by the due date and time indicated to receive credit</u>. Late work <u>will not</u> be accepted or graded unless this has been discussed with <u>and approved</u> by the professor **BEFORE** the due <u>date</u> (not the due time) of the assignment.
