## **Course Overview and description**

ACCT 4305. Federal Tax Accounting-I. 3 credits.

Study current income tax law and regulations with special emphasis on income tax legislation, treasury and court decisions, departmental rulings, income tax problems and returns, social security, and self-employment taxes.

**Prerequisite (s):** ACCT 2301 and junior standing. Credit for both ACCT 4305 and FIN 4305 will not be awarded.

## **Course Objective or Goal**

A student who successfully completes the course will be able to:

- 1. Understand the purposes of the Federal law and the legislative, administrative, and judicial sources.
- 2. Identify the determinants of taxable income, exclusions, and individual deductions.
- 3. Become familiar with the other components that relate to the theme of tax liability determination.
- 4. Demonstrate the competency to prepare the basic individual tax returns (or participate in the IRS VITA basic exam and pass with 80 or more grade).

## **COURSE REQUIREMENTS**

There will be a variety of graded and non-graded activities throughout the semester. Each activity will assess your command of the material as well as your understanding of the course goals and concepts. Activities are assigned and completed during the class period unless otherwise noted and cannot be turned in later or if classes are missed.

Weekly discussion (20%): Discussion questions are based on the weekly articles provided by the instructor on Canvas, and generally are due on Thursday at 11:59 p.m. Students pick up any one of the articles, and share your personal opinions on:

- a. Does this research ultimately contribute in any significant way to your understanding of the subject, why or why not?
- b. What are the three or four significant points you gained from the review of this research?

**Homework (30%)** are from Connect with unlimited attempts to practice, generally due on Saturday night at 11:59 p.m.

**Assessment (30%)** are from Connect with two attempts to evaluate each students' learning and generally due on Sunday night at 11:59 p.m. Basically, the assessment is made of 20 multiple choice questions. Some of the questions do need calculation to select the right answer. Solutions are visible after the due date.

Critical Thinking-Simulations (20%) are tax forms/projects on Connect and generally due on Sunday night at 11:59 p.m. Students have three attempts to work on the tax forms. The solutions are visible after the initial submission.
