### **Writing Instructive (WI) Course Description**

This is a Writing Instructive (WI) course. Writing is an important component of any criminal justice career. Criminal justice agents communicate what they do in police reports, administrative reports, as data analysis, when performing community outreach, and when they work with other agencies. Whatever your field, writing will be important! To help you improve written communication, writing will be an integral component of most assignments. The goal is to help you, not penalize you, so students receive feedback on all assignments and the opportunity to resubmit, if necessary.

### **Course Description**

CRIJ4316 (WI) This course is an introduction to the methods of criminological and criminal justice research, with emphasis on research ethics, research design, and methods of data collection and analysis.

### **Course Learning Objectives (CLO)**

The goal of the course is to help students become familiar with the methods used by social scientists to research crime, crime control policies, and programs. By the end of this course students should be able to,

1. writing skills appropriate to the discipline of Criminal Justice.
2. understanding, value, and practice of ethical behaviors associated with social science research.
3. comprehension of basic social science research methodologies as applied to research in Criminal Justice and Criminology.
4. Understand the steps involved in criminal justice research.

### **Major Course Requirements**

**Writing Instruction** Writing is a significant aspect of this course and significantly affects scores. Overall, writing should be concise, without losing important information, and submission should be well organized. All written assignments must be your own work. You may not copy from any sources, including the articles you read, without properly citing. Failing to cite is plagiarism.

[Plagiarism](#) is a form of theft. Plagiarism occurs when someone presents another person's thoughts or work as their own. Someone presents another person's thoughts as their own when they do not give credit to the source of the information by including a citation at the end of the statement *sentence*.

**Written Assignments (60%)** Written assignments assess your ability to apply the material. Students receive opportunities to improve. All written assignments should include citations in the text and a reference section. In this course we use American Psychological Association [APA](#).

**Media Assignments (10%)** Media assignments put the material you are learning into real-world context. Students learn, how to read peer-reviewed articles, the importance of research in criminal justice, the challenges with criminal justice data, and the benefits of using evidence-based practices.

**3 Exams (30%)** Exams are multiple choice and assess a student's understanding of the information contained in the text.

### **Grading Criteria Rubric and Conversion**

**Accessing Grades** Students can view their grades in the Canvas Gradebook by going to "Grades" link on Canvas. Most grades are available immediately. Grades for written assignments are returned within 7-10 days of the due date.

**Grading Rubric** A C grade is average, to earn an overall grade higher than a C you must consistently produce high quality and outstanding work. See individual assignments for more detailed rubrics.

- A, 90-100: Outstanding work and mastery of material.
- B, 80-89: High quality work and good understanding of the material.
- C, 70-79: Satisfactory work and basic understanding of the material.
- D, 60-69: Missing work and insufficient understanding of the material.
- F, <59: Missing work and no understanding of the material.

**Earning a 0** Plagiarism is a deliberate attempt to deceive the grader into believing that you produced the work. In this class and others what you write is used to assess how well you learned the material. If the material presented is someone else's, the assessment is not of you. Consequently, students who plagiarize receive a 0.

**Attendance** A student is considered attending the course if they are completing assignments regularly. If students do not complete assignments regularly, they may be marked as "not attending" which can affect enrollment status and financial aid. ## **University Library & Archives**

The University Library & Archives provides many services in support of research across campus and at a distance. We offer over 200 electronic databases containing approximately 400,000 eBooks and 82,000 journals, in addition to the 96,000 items in our print collection, which can be mailed to students who live more than 50 miles from campus. Research guides for each subject taught at A&M-Central Texas are available through our website to help students navigate these resources. On campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

Research assistance from a librarian is also available 24 hours a day through our online chat service, and at the reference desk when the library is open. Research sessions can be scheduled for more comprehensive assistance, and may take place virtually through WebEx, Microsoft Teams or in-person at the library. Our 27,000-square-foot facility on the A&M-Central Texas main campus includes student lounges, private study rooms, group work spaces, computer labs, family areas suitable for all ages, and many other features. Services such as interlibrary loan, TexShare, binding, and

### **University Writing Center**

University Writing Center: Located in Warrior Hall 416, the University Writing Center (UWC) at Texas A&M University–Central Texas (A&M–Central Texas) is a free service open to all A&M–Central Texas students. The hours of operation are from 10:00 a.m.-5:00 p.m. Monday thru Thursday in Warrior Hall 416 (with online tutoring available every hour as well) with satellite hours available online only Monday thru Thursday from 6:00-9:00 p.m. and Saturday 12:00-3:00 p.m.

Tutors are prepared to help writers of all levels and abilities at any stage of the writing process. While tutors will not write, edit, or grade papers, they will assist students in developing more effective composing practices. By providing a practice audience for students' ideas and writing, our tutors highlight the ways in which they read and interpret students' texts, offering guidance and support throughout the various stages of the writing process. In addition, students may work independently in the UWC by checking out a laptop that runs the Microsoft Office suite and connects to WIFI, or by consulting our resources on writing, including all of the relevant style guides. Whether you need help brainstorming ideas, organizing an essay, proofreading, understanding proper citation practices, or just want a quiet place to work, the UWC is here to help!
