COURSE DESCRIPTION

CRIJ 4389. Special Topics in Criminal Justice. 3 Credit Hours.

Explore selected criminal justice topics. Topics will vary according to timeliness and special needs. May be taken more than once for credit.

Expanded Course Description This course explores the evolution of criminal law. The course highlights important philosophers and scholars that help us understand the nature and purpose of the law itself.

Course Objectives Upon successful completion of this course, you will be able to:

- 1. Locate criminal codes and procedures for the state.
- 2. Understand how laws are created.
- 3. Discuss the basic requirements of all legal systems.
- 4. Discuss how and moral philosophies that shape the legal system.
- 5. Understand the purpose and function of deterrence policies.

COURSE TEXTBOOK

Course readings are included in the modules and are part of the chapter quizzes. Students will read articles discussing the philosophies and theories that make up the course. When possible, primary sources (i.e., the authors original works) are provided. If primary sources are too lengthy, complicated, or unavailable, secondary sources (i.e., someone else writing about the original work) are provided.

MAJOR COURSE REQUIREMENTS

Reading Material Quizzes (400 points, worth 50%) Students complete quizzes over the reading materials posted in the modules.

Reflections (100 points, worth 50%) These assignments ask you to think about the material you learned in the slides and read and write short 150-word responses to the question prompts. Lowest grade is dropped.

GRADING CRITERIA RUBRIC AND CONVERSION

Accessing Grades Students can view their grades in the Canvas Gradebook by going to "Grades" link on Canvas. Most grades are available immediately.

Grading Rubric A C grade is average, to earn an overall grade higher than a C you must consistently produce high quality and outstanding work. See individual assignments for more detailed rubrics.

A, 90-100: Outstanding work and mastery of material.

B, 80-89: High quality work and good understanding of the material.

C, 70-79: Satisfactory work and basic understanding of the material.

D, 60-69: Missing work and insufficient understanding of the material.

F, <59: Missing work and no understanding of the material.

STUDENT ATTENDANCE AND PERFORMANCE

Attendance Though students can <u>mostly</u> work at their own pace, if assignments are not completed regularly, they may be marked as "not attending" which can affect enrollment status and financial aid. Assignments are posted at the beginning of the semester to allow students to *mostly* work at their own pace. *However, students must complete at least one assignment during the first week of class to be marked as "attending" for the semester.* Assignments close at the end of the semester.

Early Assignments, Late Assignments, Missed Assignments Most materials are posted at the start of the semester so students who wish to work ahead can. Due dates are flexible. All assignments must be submitted by the last class day.

On campus, the library offers technology including cameras, laptops, microphones, webcams, and digital sound recorders.

University Writing Center: For the summer semesters, all University Writing Center (UWC) tutoring services are entirely online.
