Jody has consulted with public and private organizations and published in numerous scholarly journals with his body of work receiving over 12,500 citations from articles and books. He has presented scholarly papers at National and International symposia, served on editorial review boards of *The Journal of Management, The Academy of Management Journal*, and *Organization Science*, and published articles and reviews in respected scholarly journals including: *The Leadership Quarterly, Personnel Psychology, Consulting Psychology Journal, Psychology of Religion & Spirituality, Organization Science, The Academy of Management Journal, Organizational Dynamics, Journal of Business Ethics, Journal of Occupational Behavior, Journal of Management, Journal of Management Spirituality and Religion, Public Integrity, Journal of Marketing Research, Public Choice, Human Relations, Journal of Applied Psychology Journal of Management Development*, and *The Academy of Management Review*. His present research, consulting and executive development interests are focused on maximizing the triple bottom line through spiritual leadership to co-create a conscious, flourishing world that works for everyone.

More recently, Dr. Fry has extended his work on spiritual leadership to the field of sustainability, resulting in publications titled *Cultivating a Global Mindset Through Being-Centered Leadership* and *Embedding Sustainability in the Triple Bottom Line through Spiritual Leadership*. This work also grounds his teaching of leadership formation and global leadership for sustainability as part of the MS One Planet Leadership Program.
