Leadership

- Provided senior leadership in working with campus and community leaders to build 13 offices/units on-campus over the span of 10 years, which include: Campus Recreation; Career and Professional Development; Student and Civic Engagement, including new student programs, Student Organization Center; Student Conduct; Warrior Center for Student Success, Equity, and Inclusion, including academic support programs, disability and access, study abroad, Testing Center, and Tutoring Center; and Student Wellness and Counseling Center. Successfully secured funds to appropriately staff offices and fund operational budgets, design office workspaces, and ensure administrative processes were adequate.
- Integrated career connectedness, diversity and inclusion, student success, and civic engagement elements across the student experience, including service-learning, study abroad, student engagement and organizations, internships, student conduct, etc.
- Oversaw the creation of the Student Government Association and provide effective leadership for the organization.
- TAMUCT, a military friendly university, was designated as a *Great College to Work* for by The Chronicle in 2014, 2015, and 2016.
- My peers, Vice Presidents of Student Affairs across the Texas A&M System, twice elected me as the chair of the Texas A&M System Council of Vice Presidents for Student Affairs within the last three years. In my work in this group, I coordinated the discussion and resolution of important system-wide initiatives facing small and large campuses and was the governmental policy liaison working with revising drafted state law and policy that required detailed review and financial analysis for a system with more than 152,000 students. This included chairing the Annual Texas A&M System Student Affairs Symposium, which is a professional development conference for student affairs staff and student leaders.
- Received the EverFi Inaugural Campus Prevention Network Seal of Prevention for exemplary efforts to foster student safety, well-being, and inclusion through online prevention programs.

Strategic Planning, Budgeting, Assessment

- Developed division-wide assessment and continuous improvement processes, which include annual reporting of outcomes and adoption of the Council for the Advancement of Standards (CAS) for program reviews cycles.
- Worked with the community leaders and the Office of Advancement to raise funds for key areas including sponsoring programs, internships, scholarships, etc. Key projects included renaming of the Career and Professional Development Center, annual scholarship funding for student ambassadors on campus, and the initiation of the \$32,000 endowment fund for the Student Campus Cupboard.
- Ensured the Division of Student Affairs related SACSCOC standards or principles were in compliance, which had no recommendations during the for the 2013 and 2018 site visits.

- Worked with faculty members and enrollment management to create an environment to implement a philosophy of student success, including implementing an early alert program and behavioral intervention team, and advocated for faculty to gain increased accessibility to key student success data.
